

ORDINANCE NO. 179

AN ORDINANCE ENTITLED “AN ORDINANCE AMENDING ORDINANCE NO. 125” ‘AN ORDINANCE ENTITLED AN ORDINANCE PROVIDING FOR THE COLLECTION AND DISPOSAL OF GARBAGE, RUBBISH AND WASTE AND SETTING THE FEES THEREFORE.

Establishment of Authority

The City has the authority to contract for solid waste pickup and disposal within the corporate limits of the City.

Billing

The City shall bill monthly for solid waste pickup and disposal for the previous month’s solid waste services. The contractor shall notify the city for any additional charges each month.

Waste Receptacles

All outside storage of solid waste with the exception of yard waste shall be in a maximum 90- gallon capacity, metal or high impact plastic receptacle with a tight-fitting lid. Dumpsters obtained from the contractor are also acceptable.

Preparation of Garbage and Refuse for Collection

- A. All garbage shall be bagged before placing same in garbage containers; and
- B. Ashes must be placed in metal containers having a capacity not to exceed ten gallons and shall have covers.

Waste Reduction

The City promotes recycling whenever possible.

Collection Dates and Locations

- A. The contractor shall designate trash collection day(s). The City Council may alter the refuse and garbage collection schedule when deemed necessary for the public welfare
- B. The trash receptacle(s) shall be placed curbside or ally side on the designated trash collection day.

Method of Disposal – Restrictions

Solid Waste shall be disposed of as follows:

- A. The contractor shall dispose of all collected garbage and refuse by the sanitary fill method at a location approved by the City and State Department of Health.
- B. Burning of solid waste is prohibited within the city.

Rates for Service

The Council shall set Rates for the collection and hauling of garbage and refuse except trees and bulky articles from residences, public buildings and other premises. Payment shall be made monthly at the office of the City Finance Officer and the monthly rates for the various classes shall be assessed against the occupant and if the premises are not occupied against the owner thereof, and the amount shall be billed with and collected with the collection of the water and sewer service of said City.

The following schedule of rates and charges within and without the City for sanitation service is hereby established for all residential dwellings, schools and commercial businesses:(Commercial rates are determined by Heartland Waste Management.)

Mandatory Payment of Monthly Fees

The business and commercial rates shall be a mandatory fee on each business in the City. The fee shall be applied to each business entity whether the business is in the same building or structure as other businesses. The fee shall be applied to each separate business and the business shall be required to pay the fee even if the business' garbage is deposited in the garbage cans of another business or whether the business disposes of their garbage in some other manner. Residential garbage fees shall be paid for each separate dwelling unit in the City. For example, if a home owner lives in a home and has the basement rented out for dwelling purposes, each of the separate dwelling units in the home shall be assessed the residential fee for garbage pickup and it shall be mandatory that the fee be paid for each dwelling.
