

AN ORDINANCE TO AMEND SECTION ONE OF ORDINANCE ONE RELATING TO THE TIME AND PLACE FOR REGULAR MEETINGS OF THE COMMON COUNCIL OF THE CITY OF COLOME.

BE IT ORDAINED by the Common Council of the City of Colome, Tripp County South Dakota.

Section 1. That Section one of Ordinance number one be and the same is hereby amended to read as follows:

Section 1. That the regular meetings of the Common Council of the City of Colome shall be held on the first Tuesday of each month, at the hour of eight o'clock P. M. That the place of regular meetings shall be in the council chamber of the city hall of said City of Colome.

Section 2. This ordinance shall take effect and be in force twenty (20) days from and after its passage, approval and publication.
