Special Meeting Minutes  
September 18<sup>th</sup>, 2025

Mayor Kelly Leighton called the meeting of the Colome City Council to order at 7:00 PM at the Colome City Hall. The council members present were Dougherty, Duffy, Heese, Nelsen; Hill and Kutz were absent. Also, present was Finance Officer Bobbi Harter, Utility Manager Casey Harter and William Heese. The meeting was opened with the Pledge of Allegiance.

**New Business-** Motion by Dougherty, seconded by Nelsen, to approve the retail on-sale liquor license for Sportsman Lodge and Event Center and have finance officer Bobbi Harter send it to the department of revenue motion carried 3-0. Heese abstained due to conflict of interest

William Heese spoke to the council about the BBB tax that the city was giving the Colome Development Corporation at one point. Duffy made a motion to continue the topic to October's regular meeting seconded by Nelsen motion carried 4-0.

William Heese on behalf of the Development Corporation discussed with the council the idea of in the future putting in a splash pad near the city park.

There was discussion on the delivery of the drafted notification letters for the residents that have water service lines that are made of galvanized material.

Motion by Heese second by Nelsen to purchase an 18" Auger digger and a set of carbide teeth in the amount of \$3,300.00 Dougherty aye, Duffy aye, Heese aye, Nelsen aye motion carried 4-0.

**Building Permits-** Motion by Heese, seconded by Nelsen, to approve Thomas Kubal's 2025.20 building permit for a shed to be built on parcel 50.33.33.06.1 All ayes, motion carried 4-0.
